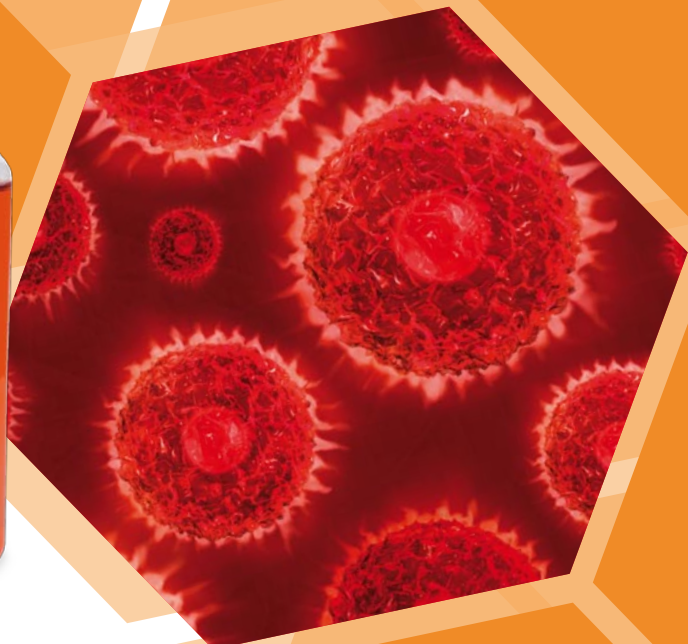

As part of the stringent quality system, ante- and post mortem inspections of all animals are undertaken by government veterinary officials. In addition, testing for specific diseases such as Bovine Spongiform Encephalopathy (BSE or Mad Cow Disease) is also conducted on FBS from some origins.



# Foetal Bovine Serum

Bovogen Biologicals' international FBS supply partners operate under strict GMP in fully validated, purpose built facilities outside of Australia. All serum is fully traceable from the source to the bottle and supported with full quality documentation.

Bovogen Biologicals' FBS of non Australian origin is produced outside Australia in facilities that are either approved by the United States Department of Agriculture (USDA) and/or the European Union (EU).

In addition, most FBS offered by Bovogen Biologicals is certified by the European Directorate of Quality Medicines (EDQM) with a Certificate of Suitability.

This certification meets the criteria described in the current version of the monograph "Products with Risk of Transmitting Agents of Animal Spongiform Encephalopathies No. 1483 of the European Pharmacopoeia.

In collaboration with our international industry partners, our commitment to quality enables Bovogen Biologicals to provide the global life sciences industry with an affordable alternative to Australian FBS that is of the highest possible standard.
